2008 International Rally Report

Pat and I traveled to Bozeman, MT for the 51st International Rally. I was also your delegate to the Annual Delegates Meeting, and proudly carried our flag in the Opening Ceremony. We had volunteered to be on the First Timers Committee—we were first timers ourselves—so this gave us several days of early parking. Rally fees are a little expensive, especially if you need 30-amp service; so getting a few days of early parking reduces the overall cost of the rally. We intend to volunteer again for the 2009 International Rally.

We left Central Florida on June 1st and traveled west to Natchez, MS. From Natchez we followed the Great River Road north to Minnesota, and then went west to Bozeman. I blogged the whole trip on my website www.silvercabin.net so some of what I say here, you may have read before if you followed our trip on the Internet.

Our assignment for the First Timers Committee was to build a list of the necessary facilities and services nearest to the rally site. This was perfect for us, as we like to get out and explore the area. We also had several open days, which allowed us to make side trips to Yellowstone NP, Three Rivers, Virginia City, Nevada City, and Butte, MT all very interesting places to visit.

At the rally, there were plenty of seminars, activities, displays, and meetings scheduled to keep everyone busy and entertained. By arriving several days before the official opening of the rally, we were witness to the many activities and volunteer workers on site to perform them. I continue to be awestruck by the amount of activity and how it all comes together to make a successful rally. There were so many things that I wanted to do that I didn't get to them all. Frequently, I found that what I had to do (IBT Seminars, Delegate Functions, Officer Training) prevented me from doing the things I wanted to do (Intro to Caravanning, Digital Photography, Genealogy Seminars).

Counting the Opening and Closing Ceremonies, there were seven nights of entertainment. We of course, attended the Opening Ceremony, but we only managed to attend two other evenings. There were so many great restaurants in Bozeman and

nearby, that often we didn't get back in time to attend the evening program. Frankly, we didn't really enjoy the two nights we did attend. Wylie and the Wild West are a mournful cowboy singer and his sidekick. Wylie's claim to fame is that he does the "Ya Hoo" for the Yahoo website commercial on TV. He did have one up-tempo number, but the rest were really downers—now I know why country music is said to induce alcoholism. The other group we saw was The Stratus Trio from Calgary. They were introduced as a cross between Peter, Paul, and Mary and the Smothers Brothers—at least they didn't make you want to slit your wrists. I did hear that the WBCCI orchestra was good.

The evening before the Delegates Meeting, a happy hour was held on the rally grounds for everyone to meet the *candidates* for election to the IBT. None of the *nominees* attended, which I found to be little snobbish, because I would have liked to have a discussion with everyone who I was being asked to vote for. Nevertheless, I had good discussions with Leo Garvey, Pat McFadden, and Bob Thompson and convinced myself to give them the Florida Unit votes. I probably would not have voted for Bob Thompson if I had a chance to read the rather angry letter he had sent to the IBT President Jerry Collins. I had asked for a copy, but no one was able to produce it then. It's on the Internet now, and Bob was suspended for a few months from the WBCCI for it—I don't think I agree with that action, but that's a subject of another discussion.

Needless to say, at the Delegates Meeting the next morning all the *nominees* were elected. Prior to the elections, we were handed a matrix and instructions on how to allocate our Unit's votes based on how they were cast in the Unit membership voting. Only a few Units did that, most voted all their votes, as I did, for a single candidate for an office. So there is a hint that all Units should be casting proportional votes instead of block votes. This needs to be clarified before next year's International Rally.

In the days after the Delegates Meeting I attended a Members Idea Share sponsored by the 2020 Committee, the four sessions of Unit Officer Training, a seminar on what makes a good rally, and I met and had a chance to talk with Dale "Pee Wee" Schwamborn Wally Byam's cousin. Pat had fun participating in the Walking for Fun, Knitting,

Pet Show, and shopping the vendors and the shops in town only a short bicycle ride away. We attended the Region 3 Brunch and had a very good meal and got a chance to get acquainted with our new Region 3 leadership.

I heard from several sources that they had a very good children's/youth program this year, and they are planning an even better one for Madison next year. This is just what we need to encourage participation from our younger, still working families.

We left a day early fleeing a forecast of 102 degree temperatures and severe weather, and went north to Great Falls, MT. On the next day when Bozeman emptied out, there were more Airstreams in the Wal*Mart parking lot in Great Falls than you see at the factory! We continued north to Glacier NP; Calgary, AB; Banff NP; and Lake Louise—gorgeous scenery. We then returned east via US-2 through the UP of Michigan before turning south towards Florida and home. This was the longest trip we have taken in our Airstream so far (73 days), and we are looking forward to Madison next year and our first Caravan, the Nor' by Nor' East.

A bit of travel news from our Prescott, AZ members:
Bob & Monteze Deputy

(Health) I guess getting older isn't for sissies. I tried getting some dental work done here. Excellent work but the expense was astronomical. A friend recommended a dentist in Mexico and I have been going down there to get things back in order. He does great work for about 20% to 40% of what they charge here.

(Travels) We tried going up to Utah for a week with the Airstream. We left Friday evening and stayed that night at Wal-Mart in Page, AZ. It was a welcome sight and the accommodations were great. Next day we traveled on up Hwy 89, then at Mt. Carmel Junction we took Utah Hwy 12 up to Torry. It is a beautiful trip from the lower elevations near Kodachrome Basin up through the highlands and back down a bit to Torry. There are beautiful forests and great long-range vistas. We went on up to Fish Lake and took a spot in the campground there. It was cool and very nice, but in the middle of the night Monteze had a bout with altitude sickness. Fish Lake is around 9,000 ft., so we left there at 2AM went back SE to Hite Crossing on the Colorado River and finished the night in a scenic

overlook high above the Colorado River. Ten years ago this area used to have what seemed like 1,000 boats on the river on piers and anchored in the basin. This year there were about 6 boats. We camped in an unimproved area mostly defined by picnic tables. Nice! Drove the Land Rover for about 20 mi. up the river on one of the scenic back roads.

We had originally planned to spend some days up above the little town of Castle Dale, UT, at a place called Joe's Valley. We never quite got there due to the altitude problems. Central Utah is beautiful but the elevations are very high. Maybe we will try it again sometime in the future, but after her experience I expect Monteze will just want to go back to Durango, CO, again.

I think we will try to go up to the south rim of the Grand Canyon for the Columbus Day holiday, or just camp in the forest south of Williams, AZ. There are some little lakes there and the forest is nice. Also it's fun to take the Rover up to the top of Bill Williams Mt. The sunset is beautiful!
